2. Data processed, Purposes, Legal Basis:

- 3. Retention period of personal data: data shall be kept for a maximum of 12 months.
- **4. Data processing method:** your data shall be processed either in paper format or by automated means.
- **5.** Recipient categories:

We inform you that your data will be stored at our headquarters and will be communicated exclusively to parties expressly authorized by the Data Controller, competent for the performance of services necessary for proper management of the relationship, with a guarantee of protection of the rights of the data subject.

Your data will not be disseminated and will not be transferred to any non-EU country or International Organisation.

- 6. We also inform you of the following rights you may have against the Data Controller:
 - Right of access by the Data Subject (art.15).
 - Right to rectification (art.16) or right to erasure (art.17).
 - Right to restriction of processing (art.18) or right to object (art.21).
 - Right to data portability (art.20).
 - Right to revoke the consent given for one or more specific purposes, at any time, without prejudice to the processing carried out prior to the withdrawal of consent (of which they may request cancellation).
 - Right to propose a complaint to the Guarantor for the protection of personal data (art.77)

Finally, we inform you that the provision of your personal data is necessary for the management of personnel selection procedures and the refusal to provide them implies the impossibility to exactly fulfill the pre-contractual obligations and to give information on personnel selection procedures
